



## OMA reports 2.20 million passenger traffic in March 2023

**Mexico City, Mexico, April 5, 2023**—Mexican airport operator Grupo Aeroportuario del Centro Norte, S.A.B. de C.V., known as OMA (NASDAQ: OMAB; BMV: OMA), reports that terminal passenger traffic at its 13 airports increased 21.3% in March 2023, as compared to March 2022. Domestic traffic increased 19.8%, and international traffic increased 31.5%.
