ITEMS FORBIDDEN IN CARRYON LUGGAGE PAST PASSENGER INSPECTION POINT AND THAT AIRLINES MAY ALSO FORBID IN CHECKED LUGGAGE.

LIST OF ITEMS:

- Weapons and ammunition.
- Flare pistols.
- Starter pistols.
- Hand grenades.
- Pellet guns.
- Axes.
- Truncheons.
- Blasting caps or detonators.
- BB guns.
- Bows and arrows.
- Brass knuckles.
- Billy clubs.
- Compressed air guns.
- Mountain climbing spikes / ice picks / ice axes
- Utility knives, daggers or stylus.
- Letter openers, scalpels
- Pepper sprays, mace, etc
- Swords, sabers, machetes and similar
- Knitting needles.
- Harpoons and other submarine weapons.
- Tear gas.
- Toy weapons.
- Cattle prods, stun guns and shocking devices.
- Lighters, high intensity bulbs.
- Spillable and gel batteries (except those in wheelchairs or similar)
- Gas torches, torch lighters, and object that use gas to weld.
- Acids or corrosives.
- Methane.
- Butane gas.
- Carbon dioxide cartridges.
- Dry ice (no more than 2 lt.).
- Fireworks and any kind of gunpowder.
- Flammable liquids.
- Gasoline.
- Insecticide.







- Lighter fluid.
- Strike anywhere matches.
- Liquid oxygen (as long as it's not medically prescribed).
- Aerosols, spray paints, liquid or gel alcohol (over 250 ml)
- Solvents.
- Acetone, polish, adhesives, oven cleaners, pipe cleaners (over 250 ml)
- Radioactive materials.
- Chlorine (pools and spas) and liquid bleach.
- Poison.
- Personal hygiene products (perfumes, hairspray) less than 2kg or liters per passenger.
- Other flammable liquids (Peroxide, notromethan and nitro methane or similar)
- Other flammable solids (magnesium, hexamine or similar)
- Box cutter
- Liquid or gel alcohols, less than 250ml.
- Oxygen canisters including chemical oxygen generators, and scuba tanks.
- Compressed Gas cylinders, including fire extinguishers (acetylene, argon, carbon dioxide, helium, nitrogen, propane, butane, hydrogen, liquid gas coolants, ammonia and refrigerated liquid oxygen) except medically prescribed oxygen.
- Portable electric drills.
- Portable electric saws or chain saws.
- Straight razors (barbershop type) or double edged old fashioned razors.
- Scuba lamps and others that produce excessive heat such as photography lamps.
- Welding articles.
- Mercury barometers or industrial thermometers.
- Gas or carbon dioxide cartridges for hair roller heating devices.
- Individual packing or insulating packing that has refrigerated liquid nitrogen.
- Metal scissors with pointer tips.
- Cricket and baseball bats.
- Metal crow bars.
- Golf clubs, lacrosse sticks, pools cues ski poles.
- Hammers, screwdrivers (except those used to repair eyeglasses), wrenches and other tools (except used by crew to activate aircraft systems).
- Non radioactive medication or personal hygienic products including aerosols (except those for personal use and only in quantities not exceeding 2 kg or liters or 500 grams or ml per person)
- Chemical, biological, radiological toxic or infectious substances (rat poison, infected blood, commercial or medical isotopes).
- Alcoholic drinks with or without labels that exceed 70gl (or more than 5liters of alcoholic drinks or liquors)

Note.- The above list is subject to change due to technologic substances or trends due to illegal interference acts.
